Booth Size: 10' wide x 10' deep (Maximum 150 booths only are available)

Booth Cost: \$350.00 per regular booth or \$400.00 per corner booth (25% off on the second regular booth)
\$450.00 per regular food booth or \$500.00 per corner food booth (25% off on the second regular food booth). **Cost subject to change. Sign up before July 31, 2011 to guarantee the cost.**
(includes one 8' table and 2 chairs, plus 6 Exhibitor's Passes)
\$100.00 additional cost for 10-minute presentation (limited number of spots)

Deadlines: \$50 deposit per booth. Full payment due to the Chinese Chamber by August 31, 2011.

Booth Terms and Conditions

1. The booths and the presentation spots will be assigned by the CCCH on a first-come, first served basis.
2. All vendors must comply with the Rules (Safety Rules) & Regulations of the Neal Blaisdell Center.
3. Vendor may set up his booth beginning at 3:00 p.m. on Friday, 10/28/11, and should begin closing no sooner than 5:00 p.m. on Sunday, 10/30/11.
4. Every food vendor is requested to provide a copy of food permit of the Health Department and follow the health requirements in operation. All food items must be prepared for cooking or serving before delivery to the Neal Blaisdell Center.
5. Water should be obtained at designated location only.
6. Rubbish and waste water should be disposed at designated location only.
7. The driveway in front of the Hawaii Suites and the parking lot by the Box Office cannot be used for loading, unloading, and parking. You should park your vehicle in the ample parking lot. Loading & unloading can only be done at the back doors of the Exhibition Hall.
8. Cancellation Rules: Upon receipt of written cancellation, there will be no penalty from 60 days prior to the Show. Afterward, a penalty of 50% of each booth rental will be charged.
9. The Chinese Chamber reserves the right to accept or reject any application at its sole discretion.
